To all to whom these Presents shall come  
Greeting

**Whereas** *The Corporations Act provides that with the exceptions therein mentioned the Lieutenant Governor may in his discretion, by Letters Patent, issue a Charter to any number of persons, not fewer than three, of ~~sixteen~~ or more years of age, who apply therefor, constituting them and any others who become shareholders or members of the corporation thereby created a corporation for any of the objects to which the authority of the Legislature extends;*

**And Whereas** *by the said Act it is further provided that the member of the Executive Council to whom the administration of this Act is assigned may in his discretion and under the Seal of his office have, use, exercise and enjoy any power, right or authority conferred by the said Act on the Lieutenant Governor;*

**And Whereas** *it has been made to appear that the persons herein named have complied with the conditions precedent to the issue of the desired Charter and that the said undertaking is within the scope of the said Act;*

**Now Therefore Know Ye** *that, being the member of the Executive Council to whom the administration of this Act is assigned,*

**I do by these Letters Patent** *issue a Charter to the Persons hereinafter named that is to say*

Terrance Edward Brooks, of The Municipality of Metropolitan Toronto, in the Province of Ontario, Barrister and Solicitor; Peter Donald Rasmussen, Barrister and Solicitor, and Richard John Oliver, Consulting Engineer, both of the City of Ottawa, in The Regional Municipality of Ottawa-Carleton, in the Province of Ontario; and Arthur Keith Jordan and Neil Hielop Stewart, both of the Township of Bathurst, in the County of Lanark, in the Province of Ontario, Electrician; constituting them and any others who become members of the Corporation hereby created a corporation without share capital under the name of

CHRISTIE LAKE ASSOCIATION INC.

for the following objects, that is to say:

(a) TO act from time to time for and on behalf of the registered owners of lots or parcels of land located in the Township of South Sherbrooke and the Township of Bathurst which abut, are adjacent to, are located on the shores of, or are in the vicinity of and have the benefits of rights-of-way or other private access to, Christie Lake and the Tay River who are members of the Corporation;

(b) TO promote the interests of the registered owners of the said lots and parcels and to advance plans for the advantage or benefit of the said lots or parcels and to promote the interests of the registered owners of the said lots and parcels relating to land use and development of the said lots and parcels and land use and development of other lots and parcels located in the Township of South Sherbrooke and the Township of Bathurst in the vicinity of Christie Lake and the Tay River;

(c) TO advance and promote measures for the protection of the environment and ecology in the vicinity of Christie Lake and the Tay River, including, without limiting the generality of the foregoing, measures to protect the purity and quality of the water in the lake and river and measures to preserve the area as a rural and residential and recreational area;

(d) TO promote fishing and hunting and to promote the interests of the anglers and hunters in the Christie Lake and Tay River area and to promote conservation measures for the area;

(e) TO promote aquatic and other sporting, cultural and social activities among the members of the Corporation and their families and the other permanent and summer residents in the vicinity of Christie Lake; and

(f) TO promote measures for safety in hunting and fishing and in boating and other aquatic activities;

THE HEAD OFFICE of the Corporation to be situate in the  
said Township of Bathurst; and

THE FIRST DIRECTORS of the Corporation to be Terrance  
Edward Brooks, Peter Donald Rasmussen, Richard John Oliver,  
Arthur Keith Jordan and Neil Hislop Stewart, hereinbefore  
mentioned;

AND IT IS HEREBY ORDAINED AND DECLARED that the Corporation  
shall be carried on without the purpose of gain for its  
members and any profits or other accretions to the Corporation  
shall be used in promoting its objects.
