NOTE: If a “Skipper” is under 18 years of age, the Registration Form MUST be signed by a parent or guardian who should print his or her name below his or signature.

ACKNOWLEDGMENTS, WAIVER, INDEMNITY AND AGREEMENT

Acknowledgements

I acknowledge that:

- (a) CLSC is a non-profit organization the goal of which is to promote interest and enjoyment in sailing, knowledge of sailing techniques and skills, an understanding of “the rules of the road” and sailing etiquette, and adherence to the principles of boating safety.
- (b) The CLSC executive and members of the Race Committee are volunteers who:
 - (i) have no accreditation from the Ontario Sailing Association or other formal training in the organisation or management of sailboat races; and
 - (ii) give their time and energy so that others may enjoy the experience of organized sailboat racing.
- (c) Participating in CLSC sponsored sailing races involves risk of damage to one’s boat and its contents and injury to its crew. Some of those who participate in CLSC races may be novice sailors with very little racing experience or knowledge of racing rules and sailing etiquette which may increase that risk.
- (d) I have read and understand the CLSC General Information, CLSC Sailing Instructions and CLSC Summary of Basic Racing Rules.

Waiver of Liability and Indemnity

In consideration of CLSC permitting me, my child, grandchild, and/or other persons who may use my boat to participate in CLSC sponsored races, I hereby agree to:

- (a) waive all claims and actions of every kind (including, without limitation, claims or actions based upon negligence, error or errors of judgment, or lack of experience) for personal injury, wrongful death and/or loss or damage to property that I, or those claiming through or under me, may have at any time against CLSC, members of its Executive, members of the Race Committee and/or all other persons assisting with the organization or management of CLSC sponsored sailing races, excepting only claims or actions arising out of a willful or intentionally destructive act or omission on the part of the person against whom such claim or action is brought; and
- (b) indemnify CLSC, all members of its Executive, all members of the Race Committee and/or all other persons assisting with the organization or management of CLSC sponsored sailing races, and hold them harmless against all claims and actions of every kind (including, without limitation, claims or actions for negligence, error or errors of error or errors of judgment, or lack of experience) for personal injury, wrongful death and/or loss or damage to property which may be brought against them, or any one or more of them, by, or on behalf of, or claiming through or under, me, a child of mine, a

grandchild of mine, or any person who may use my boat my boat to participate in CLSC sponsored races, excepting only claims or actions arising out of a willful or intentionally destructive act or omission on the part of the person who claims (or persons who claim) the benefits of this Indemnity and I hereby agree that this indemnity shall be binding upon my heirs, executors, administrators and assigns.

Agreement

I hereby agree as follows:

- (a) To use my best efforts to abide by Canadian boating laws, CLSC Sailing Instructions, the CLSC Summary of Basic Racing Rules, the instructions of the Race Committee and to instruct others who may use my boat in CLSC sponsored races to do the same;
- (b) To accept the risks inherent in participating in CLSC sponsored races; and
- (c) This Acknowledgment, Waiver of Liability and Indemnity and Agreement shall remain in full force and effect from year to year until I revoke it by giving written notice of such revocation to CLSC.
